Minor problems such as Diarrhea, Coccidiosis, Wormy Stool, etc., are common and must be treated. These conditions are the responsibility of the purchaser and should be checked by a veterinarian. This also includes Parvo or Corona virus.

Minor health problems that can be cured by medication or surgery are not covered by any guarantee.

Amanda & Joshua Olney are not responsible for anything that might happen to the puppy/dog after it leaves our property.

Buyer's Responsibilities:

- Provide puppy/dog with routine preventive care, such as, but not limited to;
 - Annual physical examinations by a licensed veterinarian.
 - Follow veterinarian guidelines for vaccinations and deworming.
 - Dog will be kept in appropriate conditions for its health and welfare and will be fed suitable quality food for its age and condition.

- The Seller guarantees the above detailed dog to be a purebred Boxer, the offspring of the sire and dam also detailed above, and fully registered with AKC.
 - This dog or any of its offspring shall not be sold, leased, or given to any pet shop or research establishment.
 - *In the event the purchaser being unable to maintain the dog, or wishes to sell the dog the breeder shall be notified and shall reserve the right to take the*

dog back at any age to no cost of the breeder, above dog must be shipped back at buyers cost. (Ground or Air)
